

## **1. 3X3 BASKETBALL**

### **1.1 GENERAL TERMS**

The 3x3 Basketball tournaments shall be organised in accordance with the most recent technical regulations of the « Fédération internationale de basketball amateur » (FIBA). In any dispute, the English text shall be regarded as authoritative.

For 3x3 Basketball, athletes must be at least 17 and less than 25 years of age on January 1st in the year of the event; for 2016, athletes must be borne between 01/01/1991 and 31/12/1998.

The programme and duration of competitions shall be fixed by the Executive Committee in agreement with the Organising Committee and the CTI. In principle, the programme shall last four (4) days from the opening ceremony to the closing ceremony and include the following events:

- One (1) men's tournament: a maximum of thirty-two (32) teams
- One (1) women's tournament: a maximum of thirty-two (32) teams

Individual contests shall be organised as part of the Championship according to the FIBA 3x3 event programme. The tournaments shall be organised outdoor. An indoor venue shall be available as a backup venue in case of weather problems.

Each country may enter a maximum of twenty-one (21) persons: sixteen (16) competitors (eight (8) men and eight (8) women) and a maximum of five (5) officials.

For each tournament, each participating country may present:

- Two (2) teams of four (4) players

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **1.2 PRE-COMPETITION PROCEDURE**

The countries participating in the 3x3 basketball tournament(s) shall pay a deposit (Art. 5.4.4) of EUR 1,000 per team to guarantee registration.

This deposit shall be paid to FISU at the latest five (5) months prior to the start of the Championship; failing this, the entries shall not be taken into consideration.

The selection and seeding of teams shall be based on the results achieved at the previous edition of the World University Championship, on the FIBA World Ranking at the moment of the draw as well as on the geographical distribution of the teams.

The draw shall be made at the General Technical Meeting and the tournament shall be managed through "Event maker", the free FIBA software.

## **1.3 TECHNICAL OFFICIALS**

### **1.3.1 Nomination and costs**

Referees shall be appointed jointly by FIBA and the FISU Technical Delegate. The participating delegations shall bear their costs of travel, board and lodging in proportion to the number of teams registered (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – FIBA partnership agreement.

The Organising Committee shall announce the exact sum shortly after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

### **1.3.2 Number of technical officials needed and qualification**

Up to 8 FIBA referees shall be nominated.

## **2. AMERICAN FOOTBALL**

### **2.1 GENERAL TERMS**

The American football tournaments shall be organised in accordance with the most recent technical regulations of the International Federation of American Football (IFAF). In any dispute, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last a maximum of eleven (11) days and include:

- One (1) men's tournament
- One (1) women's tournament

Each country is authorised to enter a maximum of ninety-seven (97) persons: a maximum of eighty (80) competitors and seventeen (17) officials.

Each country may enter:

- One (1) men's team of sixty-eight (68) players forty-five (45) of which can take part in each game and twelve (12) officials
- One (1) women's team of twelve (12) players and five (5) officials playing tackle football

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **2.2 PRE-COMPETITION PROCEDURE**

The countries participating in the American Football tournament shall pay a deposit of EUR 5,000 per team to guarantee the registration of their team (Art. 5.4.4).

This deposit shall be paid to FISU at the latest five (5) months prior to the start of the Championship; failing this, the entries shall not be taken into consideration.

Further to the confirmation of payment by FISU, the Technical Delegates shall select the teams who will take part in the event, considering both the results achieved in previous FISU WUCs and the IFAF senior national team ranking. Continental distribution shall also be taken into account.

The seeding procedure shall follow the same principle as the selection criteria (FISU and IFAF ranking). The top four (4) teams of the previous WUC edition shall be seeded; further to this ranking the IFAF ranking shall be used, with special attention on the continental distribution of groups.

## **2.3 TECHNICAL OFFICIALS**

### **2.3.1 Nomination and costs**

Referees shall be appointed jointly by IFAF and the FISU Technical Delegates. IFAF shall bear the costs of travel, board and lodging for all technical officials appointed to the event (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – IFAF partnership agreement.

The Organising Committee shall provide local referees to act as timekeepers and reserve referees.

### **2.3.2 Number of technical officials needed**

There shall be a minimum of 16 and a maximum of 28 referees, according to the number of entries.

### **3. ARCHERY**

#### **3.1 GENERAL TERMS**

The Archery competitions shall be organised in accordance with the most recent technical regulations of the "World Archery Federation" (WA). In any dispute the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last five (5) days and include:

##### **I. Individual events:**

- Men:           - Recurve bow (or division)
- Compound bow
- Women:       - Recurve bow
- Compound bow

##### **II. Team events:**

- Men:           - Recurve bow
- Compound bow
- Women:       - Recurve bow
- Compound bow

##### **III. Mixed team events:**

- Recurve bow
- Compound bow

Each country is authorised to enter a maximum of seventeen (17) persons: twelve (12) competitors and five (5) officials.

In each event, each country may enter:

##### **I. Individual events:**

A maximum of three (3) competitors in each bow category and gender (three (3) RW, three (3) RM, three (3) CW, three (3) CM)

##### **II. Team events:**

A maximum of one (1) team in each bow category and gender (one (1) Team RW, one (1) Team RM, one (1) Team CW, one (1) Team CM)

Note: If a country is unable to present a compound bow team for either men's or women's events, it shall be allowed to present a gender-combined compound team to compete in the men's compound bow event (one (1) man + two (2) women, or two (2) men + one (1) woman).

### III. Mixed team events:

A maximum of one (1) team in each bow category (one (1) Mixed Team REC and one (1) Mixed Team COM)

To shoot in the elimination phase the archers can be the same ones that make the qualification or any other ones that the delegation appoint. Once both archers are selected, no replacement is allowed.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

## **3.2 PRE-COMPETITION PROCEDURE**

Three months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

## **3.3 TECHNICAL OFFICIALS**

### **3.3.1 Nomination and costs**

International technical officials are nominated and selected by the FISU Technical Delegate and WA. Travel expenses, full board, accommodation and the per diem according to the FISU-WA Partnership agreement are to be borne by the Organising Committee.

The Organising Committee shall bear the costs of travel and board for the NTOs.

Other costs are referenced in the FISU – WA partnership agreement.

### **3.3.2 Number of technical officials needed**

- 2 experienced international judges from the continent where the event is organised, but not from the host country.
- 2 experienced international judges from other continents.
- Up to 10 NTO's (ratio of 1 judge per 25 archers).

## **4. BADMINTON**

### **4.1 GENERAL TERMS**

The badminton competitions shall be organised in accordance with the most recent technical regulations of the Badminton World Federation (BWF). In any dispute the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last seven (7) days and include the following events:

#### **I. Individual Tournament**

There are five (5) disciplines:

Men's singles

Women's singles

Men's doubles

Women's doubles

Mixed doubles

A country may enter players as follows: up to a maximum of three (3) singles players in each of the singles disciplines or three (3) pairs in each of the doubles disciplines, on the condition that no player plays in more than two (2) disciplines, e.g. one (1) singles discipline and one (1) doubles discipline, or alternatively in two doubles disciplines.

#### **II. Team Tournament**

A country shall enter players in the team tournament in the following events:

One (1) men's singles player

One (1) women's singles player

One (1) men's doubles pair

One (1) women's doubles pair

One (1) mixed doubles pair

The minimum size for a team is four (4) players (two (2) men and two (2) women).

Each country is authorised to enter in each gender category a maximum of six (6) competitors

Participation in both events (individual tournament and team tournament) is subject to a maximum size of delegation. This means that each country is authorised to enter a maximum of seventeen (17) persons, of which twelve (12) may be competitors and five (5) officials.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **4.2 PRE-COMPETITION PROCEDURE**

Three months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

#### 4.2.1 Team Tournament

The event should be played in groups of 3 or 4 teams. The draw should be based on the FISU team ranking results from the last 4 team events of the teams present. The top teams should be seeded in the same order unless substantial changes have occurred since the last tournament.

After the group ranking is established, a new draw shall be made to determine the winners, losers and lower-ranked group teams that will participate in a knockout system in a quarter-final round. In this second draw the group winners are seeded. Losers in the quarter-finals will play on to establish a full ranking. Winners play semi-finals and finals. Losing semi-finalists are both awarded bronze medals.

#### 4.2.2 Individual Tournament

The seeding in the individual draw is based on the ranking in the BWF database and the FISU team ranking of the team to which the individual players belong. Exceptionally strong performance in the previous team event may also be considered by the referee in deciding the seeding.

The level of strength of the participating players in each category will determine which BWF ranking level is necessary for participants to be awarded a seeding. This threshold shall be decided by the FISU TD. The remaining number of seeds in each category shall be filled according to the FISU team ranking the players belong to. If the highest ranked player in a team is already seeded according to BWF ranking, the player ranked number two in the team shall be seeded. The referee may decide to seed a player who has done exceptionally well in the previous team event, thus not considering the team ranking principle for that player.

#### 4.2.3 Software

The software to be used for the draw shall be the one used and approved by BWF, called Tournament Planner.

This software is compatible with the BWF database for players ranking and delivers the draw and scheduling in accordance with the tournament regulations of BWF.

The software also supports the management of tournaments in real time and the scoring by umpires. Finally, the software should be compatible with the FISU Online Accreditation System.

#### 4.2.4 Draw

The draw should be done the day before the start of the tournament and the participants must be accredited at the latest at 18:00 the day before the draw.

The participants have to be screened by both CISCA and the Technical Committee.



## **4.3 TECHNICAL OFFICIALS**

### **4.3.1 Nomination and costs.**

Technical Officials shall be appointed jointly by BWF and the FISU Technical Delegate. The Organising Committee shall bear their cost of travel, board and lodging (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – BWF partnership agreement.

### **4.3.2 Numbers of technical officials and qualifications**

ITOs shall be either qualified umpires certified or accredited by BWF or umpires certified at continental level. These umpires shall guarantee neutrality in all team and individual events.

NTOs shall be accredited at continental level. When not possible, their qualification shall be the highest national accreditation/certification.

A session shall last three (3) hours, with a maximum of four (4) sessions per day.

Depending on the size of the tournament, the number of umpires may vary from twenty-four (24) to forty-eight (48), of whom eight (8) to sixteen (16) must be ITOs in order to guarantee neutrality and qualification.

## **5. BASEBALL & SOFTBALL**

### **5.1 GENERAL TERMS**

The Baseball and Softball tournaments shall be organised in accordance with the most recent technical rules of the World Baseball Softball Confederation (WBSC). In any dispute the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last ten (10) days and include the following events:

- One (1) men's tournament with a maximum of twelve (12) teams
- One (1) women's tournament - maximum twelve (12) teams

Each country is authorised to enter one (1) team in each tournament.

Each country is authorised to enter:

- Baseball: a maximum of twenty-seven (27) persons - twenty-two (22) competitors and five (5) officials.
- Softball: a maximum of twenty-two (22) persons - seventeen (17) competitors and five (5) officials.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **5.2 PRE-COMPETITION PROCEDURE**

The countries participating in the baseball tournament shall pay a deposit of EUR 5,000 per team to guarantee registration (Art. 5.4.4).

This deposit shall be paid to FISU at the latest five (5) months prior to the start of the Championship; failing this, the entries shall not be taken into consideration.

#### **5.2.1 Baseball**

The registered teams shall be seeded according to the previous events results (WUC and/or Universiade), the WBSC ranking and continental representation.

After the closing of entries, FISU and the Organising Committee shall organise a draw in accordance with the WBSC rules. Participating teams shall be divided into two groups, with a maximum of 6 teams in each group.

The competition format implies round robin matches within groups: the two best teams from each group will play in the semi-finals and final as well as in the bronze medal games. Team ranked from the 3<sup>rd</sup> place and lower in each group will play play-down.

### 5.2.2 Softball

When there are twelve (12) effective entries, (2) sections shall be formed. A single round robin tournament shall be played within each section. The top four (4) teams from each section shall play in a double page system playoff.

The allocation to sections will be:

Teams shall be allocated to sections on the basis of their ranking in the previous FISU event results (World University Championships and/or Universiade), their WBSC world ranking at the moment of the draw as well as continental representation.

## 5.3 TECHNICAL OFFICIALS

### 5.3.1 Nomination and costs

Referees shall be appointed jointly by WBSC and the FISU Technical Delegate. The participating delegations shall bear their costs of travel and board in proportion to the number of teams registered (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – WBSC partnership agreement.

The Organising Committee shall announce the exact sum shortly after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

### 5.3.2 Number of technical officials needed and qualification

The total number depends on the number of participating teams.

## **6. BEACH VOLLEYBALL**

### **6.1 GENERAL TERMS**

The Beach Volleyball tournament shall be organised in accordance with the most recent technical regulations of the "Fédération Internationale de volley-ball" (FIVB). In any dispute the French text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last five (5) days and include:

- One (1) men's tournament: a maximum of thirty-two (32) teams
- One (1) women's tournament: a maximum of thirty-two (32) teams

For each tournament, each country is authorised to present two (2) teams of two (2) players without substitutes. Two doublets maximum per country and per gender may be presented.

Countries entering two (2) competitors may include a maximum of two (2) officials in their delegation.

Countries entering four (4) or more competitors may include a maximum of five (5) officials in their delegation.

Each team shall inform FISU and the Organising Committee of their team composition at the latest 14 days prior to the competition.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **6.2 PRE-COMPETITION PROCEDURE**

The countries participating in the beach volleyball tournament(s) shall pay a deposit (Art. 5.4.4) of EUR 500 per team to guarantee registration.

#### **6.2.1 Seeding procedure**

Two teams of the same country cannot be drawn in the same pool

- a. Hosting country team #1 will be seeded #1;
- b. Medallists of the last WUC will be seeded #2, #3 and #4;
- c. FIVB individual ranking points will be used to determine the following seeds;
- d. For the remaining teams with no ranking points, the positions will be drawn.

#### **6.2.2 Competition format**

##### **Phase 1:**

Round robin pools of 4. First 3 of each pool go to 24 single elimination bracket. The 4th of each group plays ranking games from 25 to 32.

##### **Phase 2:**

- 24 single elimination bracket
- Ranking games from 5 to 24
- Ranking games from 25 to 32

## **6.3 TECHNICAL OFFICIALS**

### **6.3.1 Nomination and costs**

Referees shall be appointed jointly by FIVB and the FISU Technical Delegate. The participating delegations shall bear their costs of travel and board in proportion to the number of teams registered (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – FIVB partnership agreement.

The Organising Committee shall announce the exact sum shortly after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

### **6.3.2 Number of technical officials needed and qualification**

One FIVB Referee Delegate, who may be accompanied by a FIVB Technical Supervisor.  
4 referees per court shall be appointed.

## **7. BOXING**

### **7.1 GENERAL TERMS**

The boxing competitions shall be organised in accordance with the most Technical Rules and AOB Competition Rules of the International Boxing Association (AIBA) unless otherwise stated. In case of disagreement in the interpretation of these rules, the English text shall be regarded as authoritative.

For Boxing, athletes must be at least 19 and less than 28 years of age on January 1st in the year of the event; for 2016, athletes must be borne between 01/01/1988 and 31/12/1997.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last six (6) days and include individual events in the following weight categories:

#### **Men's competitions**

46kg - 49kg, 52kg, 56kg, 60kg, 64kg, 69kg, 75kg, 81kg, 91kg, +91kg

#### **Women's competitions**

48kg to 51kg, 57kg to 60kg, 69kg to 75kg

Each country is authorised to enter one (1) competitor for each weight category. Each boxer must have a valid AIBA record book with a current medical record.

Each country is authorised to enter a maximum of twenty-two (22) participants: a maximum of thirteen (13) athletes and nine (9) officials.

Countries shall declare their starters to the Technical Committee at the latest 24 hours before the official weigh-in.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

## **7.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

The draw shall follow AIBA regulations.

## **7.3 TECHNICAL OFFICIALS**

### **7.3.1 Nomination and costs:**

Referees shall be appointed jointly by AIBA and the FISU Technical Delegate. The participating delegations shall bear their costs of travel, board and lodging in proportion to the number of athletes registered (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – AIBA partnership agreement.

The Organising Committee shall announce the exact sum after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

### **7.3.2 Number of technical officials needed and qualification**

- One AIBA Technical Delegate
- One chairperson for the competition jury
- Judges according to the number of entries

## **8. BRIDGE**

### **8.1 GENERAL TERMS**

The Bridge competitions shall be organised in accordance with the most recent technical rules of the World Bridge Federation (WBF) unless otherwise stated. In case of disagreement in the interpretation of these rules, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last six (6) days.

Each country is authorised to present three (3) teams of six (6) persons.

Each country can register a delegation composed of a maximum of eighteen (18) competitors and five (5) officials.

The event shall be disputed by teams of four (4) players in a round robin competition.

The OC shall provide the necessary hardware ("bridge mats") and software to broadcast the Championships online via "running scores" and BBO ("Bridge Base Online"). At least one (1) match per round shall be broadcast via BBO.

### **8.2 PRE-COMPETITION PROCEDURE**

Three months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

The draw is done by computer software to determine the schedule of the Championship. In case of an odd number of teams, at each round, one (1) team will receive a bye.

### **8.3 TECHNICAL OFFICIALS**

#### **8.3.1 Nomination and costs**

Referees shall be appointed jointly by WBF and the FISU Technical Delegate. The Organising Committee shall bear their costs of travel and board (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

The costs of the Tournament Director shall be borne by the World Bridge Federation.

Other costs are referenced in the FISU – WBF partnership agreement.

#### **8.3.2 Number of technical officials needed and qualification**

At least three (3) referees shall be appointed.



## **9. CANOE SLALOM**

### **9.1 GENERAL TERMS**

The Canoe Slalom and Wildwater competitions shall be organised in accordance with the most recent technical regulations of the International Canoe Federation (ICF). In any dispute the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last three (3) days and include the following events:

Each country is authorised to enter a maximum of twenty-five (25) persons: twenty (20) competitors and five (5) officials.

Each country may enter:

Not more than four (4) competing boats in each category

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **9.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

#### **9.2.1 Start order**

The organiser is responsible for the start list of the WUC. The start order shall be in reverse order of the competitors' rankings. This start list shall be based on the current ICF world ranking established at the time of the closing date for entries. Competitors without an ICF ranking shall be placed at the beginning of the start order. Their position on the start order shall be drawn by the organiser.

### **9.3 TECHNICAL OFFICIALS**

#### **9.3.1 Nomination and costs**

Referees shall be appointed jointly by ICF and the FISU Technical Delegate. The participating delegations shall bear their costs of travel, board and lodging in proportion to the number of athletes registered (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – ICF partnership agreement.

The Organising Committee shall announce the exact sum shortly after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

## **10. CANOE SPRINT**

### **10.1 GENERAL TERMS**

The Canoe Sprint events shall be organised in accordance with the most recent technical regulations of the International Canoe Federation (ICF). In any dispute the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last three (3) days and include the following events:

Men:

- Canoe1: 200m, 500m, 1,000m
- Canoe 2: 200m, 500m, 1,000m
- Canoe 4: 200m, 500m, 1,000m
- Kayak 1: 200m, 500m, 1,000m
- Kayak 2: 200m, 500m, 1,000m
- Kayak 4: 200m, 500m, 1,000m

Women:

- Kayak 1: 200m, 500m
- Kayak 2: 200m, 500m
- Kayak 4: 200m, 500m

Each country may enter only one (1) competing boat per discipline.

The delegation may include the following officials, according to the number of participants entered:

Up to nine (9) participants:	two (2) officials
Up to twenty (20) participants:	four (4) officials
Over twenty (20) participants:	five (5) officials

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **10.2 PRE-COMPETITION PROCEDURE**

Three months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

The draw of heats shall follow the ICF procedure and be conducted by the local canoe federation.

## **10.3 TECHNICAL OFFICIALS**

### **10.3.1 Nomination and costs**

Referees shall be appointed jointly by ICF and the FISU Technical Delegate. The participating delegations shall bear their costs of travel, board and lodging for ITOs in proportion to the number of athletes registered (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

The costs of travel, board and lodging for NTOs shall be borne by the OC.

Other costs are referenced in the FISU – ICF partnership agreement.

The Organising Committee shall announce the exact sum shortly after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

### **10.3.2 Number of officials**

10 ITOs and 24 NTOs shall be appointed.

## **11. CHEERLEADING**

### **11.1 GENERAL TERMS**

The Cheerleading competitions shall be organised in accordance with the most recent university technical rules of the International Cheer Union (ICU), unless otherwise stated.

The programme and duration of competitions are fixed by the FISU Executive Committee in agreement with the Organising Committee and the CTI. The competition shall last a two (2) days and include the following events:

#### **Divisions:**

Team Cheer University Premier Large Coed:	Five (5) to twelve (12) male athletes, sixteen (16) to twenty (20) athletes total
Team Cheer University Elite Large Coed:	Five (5) to twelve (12) male athletes, sixteen (16) to twenty (20) athletes total
Team Cheer University Premier Small Coed:	Four (4) or less male athletes, sixteen (16) to twenty (20) athletes total
Team Cheer University Elite Small Coed:	Four (4) or less male athletes, sixteen (16) to twenty (20) athletes total
Team Cheer University Premier All Female:	Sixteen (16) to twenty (20) female athletes total
Team Cheer University Elite All Female:	Sixteen (16) to twenty (20) female athletes total
Team Cheerdance University Pom:	Sixteen (16) to twenty (20) athletes
Team Cheerdance University Hip Hop:	Sixteen (16) to twenty (20) athletes
Team Cheerdance University Pom Doubles:	Two (2) athletes
Team Cheerdance University Hip Hop Doubles:	Two (2) athletes

#### **Structure:**

Day 1 Performance:	All teams, 25% of a 100% total score
Day 2 Performance:	All teams, 75% of a 100% total score

#### **Notes:**

Crossover of athletes is allowed within each national delegation.

One (1) team per nation allowed for divisions of Team Cheer University Large Coed (Premier or Elite), Team Cheer University Small Coed (Premier or Elite), Team Cheer University All Female (Premier or Elite), and one (1) team per nation allowed for all Team Cheerdance

divisions. The total delegation size should not exceed one hundred thirty-two (132) participants (hundred-forteen (114) athletes and eighteen (18) officials).

Each country may enter a maximum of twenty (20) athletes with two (2) alternates for each of the five (5) team divisions available to each country, two (2) athletes with zero (0) alternates for the doubles divisions following within the men and women composition criteria.

Each country may enter a maximum of twelve (12) coaches (two (2) coaches per team division, one (1) coach per double division) and a maximum of six (6) delegation officials.

Each athlete and official shall be in possession of a valid ICU ID card.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

## **11.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

The OC shall conduct the draw directly after the official registration in the presence of the FISU Technical Delegate (or his/her representative). Each completed master sheet shall be signed by the Technical Delegate.

The draw shall be carried out using the ICU-approved computerised random process.

Entries for the draw shall come from the FISU online registration system.

After the draw is completed and signed by the FISU Technical Delegate, copies for each participating country shall be made available.

## **11.3 TECHNICAL OFFICIALS**

### **11.3.1 Nomination and costs**

The Cheerleading judges and officials shall be appointed jointly by the ICU and FISU. ICU will cover their cost of travel, board and lodging from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU- ICU partnership agreement.

The Organising Committee shall announce the exact sum shortly after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

### **11.3.2 Number of officials**

A minimum of eighteen (18) ITOs and six (6) NTOs shall be appointed.

## **12. CHESS**

### **12.1 GENERAL TERMS**

The Chess tournaments shall be organised in accordance with the most recent technical regulations of the "Federation Internationale des Echecs" (FIDE). In any dispute, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee. The programme of competitions shall last a maximum of seven (7) days and include the following events:

- One (1) men's tournament
- One (1) women's tournament

Team classification shall be carried out jointly for men and women.

Each country is authorised to enter a maximum of thirteen (13) persons: eight (8) competitors and five (5) officials.

Each country may enter a maximum of eight (8) competitors:

A maximum of five (5) men and three (3) women, or five (5) women and three (3) men, or four (4) women and four (4) men

Only countries with three (3) competitors or more, of whom at least one (1) man and one (1) woman, shall be taken into account for team classification.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

Individual classification shall be based on the total of points scored during the game. In case of a tie, the winner shall be determined according to the FIDE rules and the tournament rules applicable to the concerned chess Championship.

Team classification shall be based on the total of points scored in the individual tournament and on the three (3) best scores of at least one (1) man and one (1) woman from the same country. If the number of men is equal or more than 1.5 times the number of women, team classification shall be based on the best results of two (2) men and one (1) woman. Similarly, if the number of women is equal or more than 1.5 times the number of men, team classification shall be based on the best results of two (2) women and one (1) man.

In the event of a tie, the winning team shall be determined according to the FIDE rules.

### **12.2 PRE-COMPETITION PROCEDURE**

Three months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

#### **12.2.1 Seeding method**

The seeding is made according to the international ELO-rating.

Players who do not have ELO-rating shall be placed at the bottom of the starting list in alphabetical order.

The pairing of all rounds shall be made with the latest version of Swiss Chess Software.

### **12.3 TECHNICAL OFFICIALS**

#### **12.3.1 Nomination and costs**

Referees shall be appointed jointly by FIDE and the FISU Technical Delegate. The Organising Committee shall bear their costs of travel, board and lodging (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – FIDE partnership agreement.

#### **12.3.2 Number of technical officials needed and qualification**

1 chief arbiter and 2 deputy arbiters shall be appointed.



## 13. CROSS-COUNTRY

### 13.1 GENERAL TERMS

The Cross Country competitions shall be run in accordance with the most recent technical rules of the International Association of Athletic Federation (IAAF), unless otherwise stated. In case of disagreement in the interpretation of the rules, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last one (1) day and include the following events:

Individual races and team classification

men: a minimum of 9km, a maximum of 14km, approximately 12km

women: a minimum of 4km, a maximum of 8km, approximately 6km

Each country may enter a maximum of twenty-one (21) persons: sixteen (16) competitors and five (5) officials.

Each country may enter in the events:

Men's individual event: a maximum of eight (8) competitors per country; no more than six (6) shall be allowed to start in the race.

Women's individual event: a maximum of eight (8) competitors per country; no more than six (6) shall be allowed to start in the race.

The deadline for sending the individual entries of athletes shall be fixed between the OC and FISU.

Teams shall receive the final confirmation forms upon arrival and Team Leaders, or their representatives, shall confirm the names of those athletes that are already entered and will actually take part in the competition. The final confirmation of participation shall be made for all events during the accreditation process.

Men's team classification:

The first four (4) finishers shall participate in team classification.

Women's team classification:

The first four (4) finishers shall participate in team classification.

Before the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

Team classification shall be carried out as follows:

- a) Each race shall be scored separately. The team results shall be decided by the aggregate of places recorded by the scoring athletes of each team.
- b) The team with the lowest aggregate of points will be judged the winner. If a team fails to finish with a complete scoring team, the runners finishing shall be counted as individuals in the race result and be eligible for the individual awards.
- c) In assessing the aggregate, no adjustment to the scoring of the finishing teams shall be made in respect of any non-scoring team runners or of individual entries.
- d) In the event of a tie, it shall be resolved in favour of the team whose last scoring member finishes nearer to first place

### **13.2 PRE-COMPETITION PROCEDURE**

Three months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

The draw of the start boxes shall be conducted before the first General Technical Meeting by the Race Director under the supervision of the FISU TD.

### **13.3 TECHNICAL OFFICIALS**

The Organising Committee shall appoint the necessary referees and judges at its own expenses.

## **14. CYCLING**

### **14.1 GENERAL TERMS**

The cycling competitions shall be run in accordance with the most recent technical regulations of the "Union Cycliste Internationale" (UCI). In any dispute, the French text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last minimum two (2) days and include as a minimum two (2) of the following disciplines:

Men's and women's events:

- Road events:           Road Race  
                                Individual time trial  
                                Criterium race
- Track
- Mountain bike:       Cross Country (XCO)  
                                Down Hill (DHI)  
                                Marathon
- BMX
- Cyclo-cross race

The Organising Committee shall propose a list of events and disciplines to the FISU Executive Committee at the latest eighteen (18) months prior to the Championship.

Each country may enter:

- For road race events, a maximum of six (6) men and six (6) women;
- For track events, a maximum of six (6) men and six (6) women;
- For mountain bike events, a maximum of six (6) men and six (6) women;
- For BMX events, a maximum of four (4) men and four (4) women;
- For cyclo-cross race events, a maximum of four (4) men and four (4) women.

The delegation may include the following officials, according to the number of participants entered:

- up to nine (9) participants: two (2) officials
- up to twenty (20) participants: four (4) officials
- over twenty (20) participants: five (5) officials

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

Every cyclist must have a national cycling licence that is valid for the year of the Championship and issued by his/her national federation, which shall be affiliated to UCI.

### **14.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

All procedures concerning the draw and attribution of race numbers shall follow the UCI procedures.

### **14.3 TECHNICAL OFFICIALS**

#### **14.3.1 Nomination and costs:**

Commissaires shall be appointed jointly by UCI and FISU. The Organising Committee shall bear their costs of travel, board and lodging (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

National Commissaires shall be appointed jointly by the OC and the National Cycling Federation. The OC shall bear all their costs.

Other costs are referenced in the FISU - UCI partnership agreement.

#### **14.3.2 Number of technical officials needed and qualification**

The number of technical officials needed is specified per discipline and per event in the following table.

## **15. EQUESTRIAN**

### **15.1 GENERAL TERMS**

The Equestrian competitions shall be run in accordance with the most recent technical rules of the "Fédération Equestre Internationale" (FEI). In the event of disagreement on the interpretation of the rules, the French text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last a maximum of five (5) days and include the following events for men and women:

#### I. Individual tournament:

- Show Jumping
- Dressage (optional)
- Individual combined classification (optional if dressage is organised)

#### II. Team tournament:

- Team combined classification if dressage is organised
- Team Jumping classification if dressage is not organised.

Each country may enter a maximum of nine (9) persons: four (4) competitors and five (5) officials.

In each event, each country is authorised to enter:

- a maximum of four (4) riders, of whom only three (3) may compete

The dressage and jumping events shall be organised following the knockout system, on which combined classification shall be based.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

The Organising Committee shall guarantee the provision of the necessary number of horses for all participants.

### **15.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

### **15.3 TECHNICAL OFFICIALS**

#### 15.3.1 Nomination and costs

Referees shall be appointed jointly by FEI and the FISU Technical Delegate. The Organising Committee shall bear their costs of travel, board and lodging (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – FEI partnership agreement.

#### 15.3.2 Number of ITOs

A minimum of 6 judges shall be appointed.

## **16. FLOORBALL**

### **16.1 GENERAL TERMS**

The Floorball tournaments shall be organised in accordance with the most recent technical regulations of the International Floorball Federation (IFF). In any dispute, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last from three (3) to five (5) days depending on the number of participants and include:

- One (1) men's tournament
- One (1) women's tournament

Each country is authorised to enter, for each team, a maximum of twenty-seven (27) persons: a maximum of twenty (20) players and seven (7) officials.

At the first General Technical Meeting, the Head of Delegation or his/ her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **16.2 PRE-COMPETITION PROCEDURE**

The countries participating in the Floorball tournament shall pay a deposit of EUR 5,000 per team to guarantee registration (Art. 5.4.4).

This deposit shall be paid to FISU at the latest five (5) months prior to the start of the Championship; failing this, the entries shall not be taken into consideration.

The participating teams are seeded in their groups according to their ranking. The ranking of teams for WUC competitions takes into account both the FISU and IFF rankings. The IFF ranking is used as a repair factor for the FISU ranking when teams have not participated in the same number of FISU events.

Group distribution shall be based on rankings and the number of groups is decided by the WUC Department in agreement with the Organising Committee and the CTI. The grouping shall be made after the final number of participating teams is confirmed.

The order of play within each group shall be:

4 teams: 1-2, 3-4, 1-3, 2-4, 4-1, 2-3.

5 teams: 1-2, 3-4, 5-1, 2-3, 4-5, 1-3, 5-2, 4-1, 3-5, 2-4.

6 teams: 1-6, 5-2, 3-4, 2-1, 6-3, 4-5, 3-2, 6-4, 1-5, 4-1, 5-3, 2-6, 1-3, 2-4, 6-5.

After the groups have been determined, the IFF and the CTI shall assign a number to each team within each group by drawing lots.

## **16.3 TECHNICAL OFFICIALS**

### **16.3.1 Nomination and costs**

Referees shall be appointed jointly by IFF and the FISU Technical Delegate. The participating delegations shall bear their costs of travel, board and lodging in proportion to the number of teams registered (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – IFF partnership agreement.

The Organising Committee shall announce the exact sum shortly after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

### **16.3.2 Number of technical officials needed**

IFF and the CTI shall decide on the number of referee pairs after the final number of participating teams is confirmed.

There shall be one (1) referee pair in each match and the nominations for each match shall be made by IFF.



## **17. FUTSAL**

### **17.1 GENERAL TERMS**

The Futsal tournaments shall be organised in accordance with the most recent technical regulations of the "Fédération Internationale de football association" (FIFA) applicable to Futsal. In any dispute, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last eight (8) days and include:

- One (1) men's tournament
- One (1) women's tournament

The tournament shall take place indoors.

Each country is authorised to enter a maximum of nineteen (19) persons: a maximum of fourteen (14) and a minimum of ten (10) competitors and five (5) officials per tournament.

Each country may enter:

- One (1) men's team of fourteen (14) players (5 effectives and 9 substitutes)
- One (1) women's team of fourteen (14) players (5 effectives and 9 substitutes)

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

#### **17.1.1 Competition Format, Classification**

The system of play will be the league system, each team playing one match against each of the other teams in the same group, with three points for a win, one point for a draw, and none for a defeat.

The ranking of each team in each group will be determined as follows:

- a) Greatest number of points obtained in all group matches;
- b) Goal difference in all group matches;
- c) Greatest number of goals scored in all group matches.

If two or more teams are equal on the basis of the above three criteria, their rankings will be determined as follows:

- d) Greatest number of points obtained in the group matches between the teams concerned;
- e) Goal difference resulting from the group matches between the teams concerned;
- f) Greater number of goals scored in all group matches between the teams concerned;
- g) Drawing of lots by the local Organising Committee.

The two teams finishing first and second in each group is qualify for the 2nd phase.

If the finals level at the end of normal playing time, extra time shall be played (two periods of five minutes each) and followed, if necessary, by kicks from penalty mark according to FIFA rules

#### 17.1.2 Disciplinary Sanction

In general the following will apply:

A red card will receive a minimum of one game suspension. An accumulation of two yellow cards will receive a one game suspension. Single yellow cards will be cancelled after the first phase of games and will not be carried forward into the second phase.

#### 17.1.3 Protests and Appeals

Any protest of a sport or disciplinary nature must reach the CTI through the referee or match commissioner within one (1) hour of the completion of the game.

A Head of Delegation or his deputy may file a protest against the decision of the CTI. This protest must be submitted in writing to Cisca in accordance with the regulations of the FIFA or FISU technical regulations. Such protest must be accompanied by the regulatory FISU deposit of 50 EUR, which will be returned if the protest is upheld.

### **17.2 PRE-COMPETITION PROCEDURE**

The countries participating in the Futsal tournament shall pay a deposit of EUR 5,000 per team to guarantee registration (Art. 5.4.4).

This deposit shall be paid to FISU at the latest five (5) months prior to the start of the Championship; failing this, the entries shall not be taken into consideration.

Further to the confirmation of payment by FISU, the Technical Delegates shall determine the teams who are to take part in the event, considering both the results achieved in the previous FISU WUC and the FIFA futsal ranking. Continental distribution shall also be taken into account.

The draw shall take place during the inspection visit. The seeding procedure shall follow the same principle as the selection criteria (FISU and FIFA futsal ranking). The top eight (8) teams of the previous WUC edition shall be seeded; further to this ranking, the FIFA ranking shall be used, with special attention on the continental distribution of the groups.

### **17.3 TECHNICAL OFFICIALS**

#### 17.3.1 Nomination and costs

Referees shall be appointed jointly by FIFA and the FISU Technical Delegates. The participating delegations shall bear their costs of travel, board and lodging in proportion to the number of teams registered (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – FIFA partnership agreement.

The Organising Committee shall announce the exact sum shortly after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

The Organising Committee shall provide local referees to act as timekeepers and reserve referees.

#### 17.3.2 Number of technical officials needed

There shall be as many referees as participating teams.

## **18. GOLF**

### **18.1 GENERAL TERMS**

The golf competitions shall be run in accordance with the most recent rules of Golf and Amateur Status of the Royal and Ancient Golf Club of St. Andrews, unless otherwise stated. In the event of a disagreement on the interpretation of the rules, the English text shall be regarded as authoritative.

Only players having an amateur status are allowed to compete in the event.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last four (4) days and include the following events:

- Men's individual competition (72 holes - stroke play)
- Women's individual competition (72 holes - stroke play)
- Men's team competition (72 holes - stroke play)
- Women's team competition (72 holes - stroke play)

The event will be played over 72 holes stroke-play: 18 holes each day for the four (4) consecutive days of the event.

Each country may enter a maximum of six (6) competitors.

In each event, each country may enter:

#### Men:

- Individual event: three (3) competitors;
- Team event: the two (2) best results each day shall count for the team classification per day.

#### Women:

- Individual event: three (3) competitors;
- Team event: the two (2) best results each day shall count for the team classification per day.

Each competitor shall have a handicap of nine (9) or less when entering the World University Championship.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **18.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

#### 18.2.1 Seeding Method

Seeding shall be made per country by using the team results achieved in the previous event as a guide for seeding. If the host country is not in the first five seeds, it shall be included among the first six.

Where possible, players from the same country shall be kept together in a block, one playing each time slot after another.

The draw shall be published after all countries have registered.

#### 18.2.2 Tie-breaks

In the case of a tie between two (2) competitors or more for an individual gold medal, they shall play off. For other individual medals, the most recent day's score shall decide and if there is still a tie, last 9, last 6 etc. shall be used. In the case of a tie between two (2) teams or more, the most recent day's counting team score shall decide and if there is still a tie, last 9, last 6 etc. shall be used.

### **18.3 TECHNICAL OFFICIALS**

#### 18.3.1 Nomination

International referees are nominated and selected by the NSF in agreement with FISU. Travel expenses, full board, accommodation and the per diem according to the FISU-IGF partnership agreement are to be borne by the Organising Committee.

The OC and the NSF will appoint NTOs to complement the team of technical officials required for Golf. The number of NTOs shall be agreed between the OC and the FISU TD.

#### 18.3.2 Number of technical officials needed and qualification

- One (1) international chief referee
- Two (2) domestic referees with an international referee qualification

#### 18.3.3 Duration of Stay

Unless otherwise stated by FISU, all international technical officials are to arrive one (1) day prior to their first official meeting as agreed between FISU and the OC and depart one (1) day after the end of competition.

#### 18.3.4 Per Diem

ITOs are entitled to receive a per diem in the amount established in the FISU-IGF partnership agreement for the entire days of duty.

#### 18.3.5 Accommodation

Unless otherwise stated by FISU, ITOs are to be accommodated in single rooms.

## **19. HANDBALL**

### **19.1 GENERAL TERMS**

The Handball tournament shall be organised in accordance with the most recent technical regulations of the International Handball Federation (IHF). In any dispute the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last seven (7) days and include:

- One (1) men's tournament
- One (1) women's tournament

Each country is authorised to enter a maximum of twenty two (22) persons per tournament: a maximum of sixteen (16) competitors and a maximum of six (6) officials.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **19.2 PRE-COMPETITION PROCEDURE**

The countries participating in the Handball tournament shall pay a deposit of EUR 5,000 per team to guarantee registration (Art. 5.4.4).

This deposit shall be paid to FISU at the latest five (5) months prior to the start of the Championship; failing this, the entries shall not be taken into consideration.

#### **19.2.1 Seeding procedure**

The seeding procedure shall consider several factors (in no given order)

- FISU ranking of the two previous WUCs
- Continental distribution
- IHF ranking

#### **19.2.2 Seeding of the host country**

If the host country appears in the FISU ranking as one of first four top teams, it shall be seeded in position 1 in Group A.

If the host country appears in the FISU ranking after the fourth place, it shall be seeded in position 2 in Group A.

The place and time of the seeding and drawing procedure shall be decided in agreement between the OC and FISU.

The draw shall be done manually.

## **19.3 TECHNICAL OFFICIALS**

### **19.3.1 Nomination and costs**

Referees shall be appointed jointly by IHF and the FISU Technical Delegate. The participating delegations shall bear their costs of travel, board and lodging in proportion to the number of teams registered (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – IHF partnership agreement.

The Organising Committee shall announce the exact sum shortly after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

### **19.3.2 Number of technical officials needed**

A ratio of one pair of ITOs for two teams should be respected.  
In terms of NTOs, there should be for each playing hall:

- 1 floor manager
- 1 score keeper
- 1 time keeper
- 1 delegate
- 1 announcer

## **20. KARATE**

### **20.1 GENERAL TERMS**

The Karate competitions shall be organised in accordance with the most recent technical rules of the World Karate Federation (WKF) unless otherwise stated. In case of disagreement in the interpretation of these rules, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last four (4) days and include:

#### **20.1.1 Kumite**

##### **I. Individual events**

Men:

Bouts duration: generally three (3) minutes and four (4) minutes for finals  
-60kg, -67 kg, -75 kg, -84 kg, +84 kg

Women:

Bouts duration: generally two (2) minutes and three (3) minutes for finals  
-50kg, -55kg, -61kg, -68kg, +68kg

##### **II. Team events**

#### **20.1.2 Kata**

Men and women:

- Individual events
- Team events

Each country is authorised to enter a maximum of twenty-nine (29) competitors (sixteen (16) men and thirteen (13) women) and five (5) officials. Each country may enter in:

Kata:

##### **Individual events:**

A maximum of one (1) competitor in each category

##### **Team events:**

Three (3) competitors

Kumite:

##### **Individual events:**

A maximum of one (1) competitor in each category

##### **Team events:**

Men: a team is composed of a maximum of seven (7) and a minimum of five (5) competitors

Women: a team is composed of a maximum of four (4) and a minimum of three (3) competitors



The team events shall take place after the individual events.

Each athlete and official must be able to provide evidence of WKF membership.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

## **20.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

The OC shall conduct the draw directly after the official registration in the presence of the FISU Technical Delegate (or his/her representative). Each completed master sheet shall be signed by the Technical Delegate.

The draw shall be carried out using the WKF-approved computerised random process, with the exception that the corresponding finalists of the previous Championships are separated as widely as possible.

Entries for the draw shall come from the FISU online registration system.

After the draw is completed and signed by the FISU Technical Delegate, copies for each participating country shall be made available.

## **20.3 TECHNICAL OFFICIALS**

### **20.3.1 Nomination and cost:**

Referees shall be appointed jointly by WKF and the FISU Technical Delegate. The participating delegations shall bear their costs of travel, board and lodging in proportion to the number of athletes registered (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – WKF partnership agreement.

The Organising Committee shall announce the exact sum shortly after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

### **20.3.2 Number of technical officials needed**

A minimum of 24 ITOs shall be appointed.

## **21. KORFBALL**

### **21.1 GENERAL TERMS**

The Korfball tournaments shall be organised in accordance with the most recent technical regulations of the International Korfball Federation (IKF). In any dispute, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the FISU Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last a maximum of five (5) days and include:

- A mixed tournament

Each country is authorised to enter a maximum of one (1) team of twenty-one (21) persons: a maximum of sixteen (16) players and five (5) officials.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **21.2 PRE-COMPETITION PROCEDURE**

The countries participating in the Korfball tournament shall pay a deposit of 5000 EUR per team to guarantee the registration of their team (Art. 5.4.4).

This deposit shall be paid to FISU at the latest five (5) months prior to the start of the Championship; failing this, the entries shall not be taken into consideration.

Further to the confirmation of payment by FISU, the Technical Delegate shall select the teams who will take part in the event, considering both the results achieved in previous FISU WUCs and the IKF senior national team ranking. Continental distribution shall also be taken into account.

The seeding procedure shall follow the same principle as the selection criteria (FISU and IKF ranking). The top four (4) teams of the previous WUC edition shall be seeded; further to this ranking the IKF ranking shall be used, with special attention on the continental distribution of groups.

### **21.3 TECHNICAL OFFICIALS**

#### **21.3.1 Nomination and costs**

Referees and jury-officials shall be appointed jointly by IKF and FISU. IKF shall bear the costs of travel, board and lodging for all international technical officials appointed to the event (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – IKF partnership agreement.

The Organising Committee shall provide national technical officials to act as timekeepers and shot-clock operators and if needed assistant referees.

#### 21.3.2 Number of technical officials needed

There shall be a minimum of 17 and a maximum of 22 referees + jury-officials, according to the number of entries and if the tournament is played in one hall or two halls.

## **22. MODERN PENTATHLON**

### **22.1 GENERAL TERMS**

All Modern Pentathlon – and its sub sports - shall be organised in accordance with the most recent technical rules of the Union International de Pentathlon Moderne (UIPM) unless otherwise stated by the Executive Committee. In the event of a disagreement in the interpretation of these rules, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the FISU Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last a minimum of five (5) days and include individual and relay/ team events.

Each event consists of four of the five Modern Pentathlon disciplines: fencing, swimming, combined event (running and shooting). Competitors achieve points in each discipline according to their performance. The last event is the Combined with a handicap start based on the competitors' total points from the previous events. Competitors set off at intervals which correspond in seconds to the Pentathlon point's difference between themselves and the athlete in front. The first athlete across the finish line is the overall winner.

#### **Individual Events**

Individual events shall be organised for both genders: women and men. A maximum of six (6) competitors per gender and three (3) officials and coaches per country and event can be entered. The OC and CTI can limit the number per nation to four (4).

Should the total number of competitors exceed 36, qualification competitions and a final (with 36 competitors) shall be organised; according to the UIPM technical rules.

#### **Modern Tetrathlon**

It consists of the following disciplines: Fencing, swimming and combined event (running and shooting).

#### **Disciplines**

##### **Fencing**

Each athlete will fence against all other athletes with an electric épée for one hit within a time limit of 1 minute. If the number of total fencers is less than 20, it will be necessary to fence two rounds consecutively, without the fencers leaving the piste. If a hit is not scored within the time, both competitors register a defeat.

A bonus round will be organised indoors directly after the round robin or later outdoors before the combined event.

##### **Swimming**

The swimming discipline is a 200 meters freestyle race. Athletes will be seeded into heats according to their personal best time achieved in the last 12 months in the same discipline.

### Combined event (running and shooting)

The shooting is carried out with Laser Pistols and electronic targets.

The competitor with the most points after 2 disciplines starts first in the combined event. The remaining athletes start with time handicaps (one second for every Modern Pentathlon point after two MP disciplines).

The combined event consists of four (4) series of shooting and a total distance of 3200m (4x800m) running. Starting with a short run; first shooting (5 targets hits to be shot); 800m running; followed by three (3) more series of shooting and running.

### **Mixed Relay Event**

Team of 2 athletes: 1 woman and 1 man.

The Mixed Relay event allows up to 24 relay teams on two competitors to compete in one day. Each team consists of two athletes from the same country. A maximum of two (2) teams per country are allowed.

### Fencing

Each relay team will fence against all remaining relay teams with an electric épée as in the individual competition. Athletes fence the same gender competitor. A bonus round will be organised indoors directly after the round robin or later outdoors before the combined event.

### Swimming

The swimming event is a freestyle 2 x 100 meters relay race. The women team member starts first. Teams will be seeded into heats.

### Combined event (running and shooting)

The shooting will be carried out with Laser Pistols and Electronic targets. The mixed relay team with the most points after 2 disciplines starts first in the combined event. The remaining teams start with time handicaps (one second for every Modern Pentathlon point after two MP disciplines).

The Combined event consists of four (4) series of shooting and a total distance of 3200m running as in the individual events. The women starts first and after completion of two (2) series in shooting, running and, hands over to the man.

### **Team Event**

Team of three (3) athletes, same gender.

Team competitions for women and men are organised. The Team event allows up to 24 teams on 3 competitors to compete in one day. Each Team consists of three (3) athletes from the same country. Each competitor competes in one discipline only.

## Fencing

Each athlete will fence against all other athletes with an electric épée for one hit within a time limit of one (1) minute. If the number of total fencers is less than twenty (20), it will be necessary to fence two rounds consecutively, without the fencers leaving the piste. If a hit is not scored within the time, both competitors register a defeat. A bonus round will be organised indoors directly after the round robin or later outdoors before the combined event.

## Swimming

The swimming discipline is a 200 meters freestyle race. Athletes will be seeded into heats according to their personal best time achieved in the last 12 months in the same discipline.

## Combined Event (Running and Shooting)

The shooting will be carried out with Laser Pistols and Electronic targets. The team with the most points after two (2) disciplines starts first in the combined event. The remaining teams start with time handicaps (one second for every Modern Pentathlon point after two MP disciplines). The Combined event consists of four (4) series of shooting and a total distance of 3200m running as in the individual events. The shooter hands over to the runner and vice versa until the four (4) series are completed.

## **22.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

## **22.3 TECHNICAL OFFICIALS**

### 22.3.1 Nomination and costs

ITO's shall be appointed jointly by UIPM and FISU. Their costs (travel, per diem and full board) will be covered by the UIPM. Other costs are referenced in the FISU – UIPM collaboration convention.

### 22.3.2 Number of technical officials needed

For the WUC, two (2) ITOs are needed. The host country's resources shall be considered.

## **23. MUAY THAI**

### **23.1 GENERAL TERMS**

The Muaythai competitions will be organised in accordance with the most recent technical regulations of the International Federation of Muaythai Amateur (IFMA). In case of disagreement in the interpretation of these rules, the English text will be regarded as authoritative. The most current rules and regulations can be found at [www.ifmamuaythai.org/technical-reference/muaythai-rules/](http://www.ifmamuaythai.org/technical-reference/muaythai-rules/).

The programme and duration of the competitions are fixed by the FISU Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last seven (7) days and include the following events:

The duration of each bout shall be three (3) rounds of three (3) minutes each for both male and female competitors. A full one (1) minute of rest shall be given between the rounds.

Each country is authorised to enter a maximum twenty-six (26) participants: sixteen (16) athletes and ten (10) officials.

Each country is authorised to enter a maximum of one (1) athlete per weight category per gender.

At the first General Team Manager Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors.

### **23.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

## **23.3 TECHNICAL OFFICIALS**

### **23.3.1 Nomination and costs:**

All international referees and judges shall be appointed jointly by IFMA and FISU. Travel expenses, accommodation, full board and the allowances according to the regulations of the IFMA for all international judges are borne by IFMA.

Participating countries can bring their own Team Technical Officials (TTO) whom must be approved by IFMA. Their travel expenses, accommodation and full board will be covered by their relevant National Muaythai Federation.

Remaining NTOs are appointed by IFMA and the Organising Committee will cover their travel expenses, accommodation and full board.

### **23.3.2 Number of technical officials needed**

15 ITOs/TTOs/NTOs per ring



## **24. NETBALL**

### **24.1 GENERAL TERMS**

The Netball tournament shall be organised in accordance with the most recent technical regulations of the International Netball Federation (INF). In any dispute, the English text shall be regarded as authoritative.

The programme and duration of competitions shall be fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The programme shall last up to five (5) days from the opening ceremony to the closing ceremony and include the following events:

- One (1) women's tournament: maximum twelve (12) teams

The tournament shall be organised indoors.

Each country may enter a maximum seventeen (17) persons: twelve (12) competitors and five (5) officials.

Each participating country must present:

- One (1) team composed of a maximum of twelve (12) players

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **24.2 PRE-COMPETITION PROCEDURE**

The countries participating in the Netball tournament shall pay a deposit of EUR 5,000 per team to guarantee registration (Art. 5.4.4).

This deposit shall be paid to FISU at the latest five (5) months prior to the start of the Championship; failing this, the entries shall not be taken into consideration.

#### **24.2.1 Seeding and draw**

The draw will take place during the General Technical Meeting, after a seeding is established on the basis of the results achieved in the previous WUC, the INF world ranking at the moment of the draw and continental distribution.

### **24.3 TECHNICAL OFFICIALS**

#### **24.3.1 Nomination and costs**

Umpires shall be appointed jointly by INF and the FISU Technical Delegate. The participating delegations shall bear their costs of travel, board and lodging in proportion to the number of teams registered (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – INF partnership agreement.

The Organising Committee shall announce the exact sum shortly after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

#### 24.3.2 Number of technical officials needed

A ratio of one umpire and a reserve umpire per team shall be respected.

These officials will come from the host country and neighboring countries.

A minimum of 2 scorers, 2 time keepers and 2 statistic personnel per game shall be appointed as NTOs.

The costs for the travel and the stay of the NTOs shall be covered by the Organising Committee

## **25. ORIENTEERING**

### **25.1 GENERAL TERMS**

The Orienteering competitions shall be run in accordance with the most recent technical rules of the International Orienteering Federation (IOF), unless otherwise stated. In case of disagreement in the interpretation of the rules, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last five (5) days and include the following events:

Men:

- Individual sprint distance race
- Individual middle distance race
- Individual long distance race
- Relay race

Women:

- Individual sprint distance race
- Individual middle distance race
- Individual long distance race
- Relay race

Mixed:

- Sprint relay race

Each country may enter a maximum of seventeen (17) persons: twelve (12) competitors (with a maximum of six (6) men and six (6) women) and five (5) officials.

Each country may enter in:

Long distance:	four (4) men and four (4) women
Middle distance:	four (4) men and four (4) women
Sprint distance:	four (4) men and four (4) women
Relay:	two (2) men's teams of three (3) runners and two (2) women's teams of three (3) runners
Mixed relay:	one (1) team of two (2) female runners and two (2) male runners

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **25.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

### **25.3 TECHNICAL OFFICIALS**

A jury consisting of three (3) team officials shall be appointed at the first General Technical Meeting.

The IOF Technical Delegate shall chair the jury without voting rights.  
The jury shall remain the same throughout the competition week.

## **26. ROLLER SPORT**

### **26.1 GENERAL TERMS**

The Roller Sport events shall be organised in accordance with the technical regulations of the Federation Internationale de Roller Sport (FIRS). In any dispute the English text shall be regarded as authoritative.

The programme and duration of competitions shall be fixed by the FISU Executive Committee in agreement with the Organising Committee and the CTI. In principle, the programme shall last a maximum of seven (7) days and include the following distances:

#### **Track:**

300m time-trial race  
500m sprint tournament  
1.000m sprint tournament  
10.000m points + elimination race  
15.000m elimination race  
3.000m relays

#### **Road:**

200m time-trial race  
500m sprint tournament  
10 000m points race  
20 000m elimination race  
5 000m relays  
Marathon

Each country may enter a maximum twenty (20) persons: sixteen (16) competitors (eight (8) men and eight (8) women) and four (4) officials.

Each country may enter per gender category:

Men: two (2) athletes for each distance may start in races  
Ladies: two (2) athletes for each distance may start in races

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **26.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

The procedures regarding the draw shall follow the FIRS technical regulations.

### **26.3 TECHNICAL OFFICIALS**

ITO's shall be appointed jointly by FIRS and FISU. Their costs (travel, per diem and full board) will be covered by the FIRS.

Other costs are referenced in the FISU – FIRS collaboration convention. The jury shall remain the same throughout the competition week.

The number of officials needed shall respect FIRS rules. Based on the FIRS rules it is necessary to have eight (8) International Judges appointed from FIRS CIC Chairman 30 days before the competition (chapter 2 and 3 of the FIRS CIC regulations).

The OC in cooperation with their National Roller Federation must provide the guarantee the sufficient number of Judges for the races and for all the competition days.

## **27. ROWING**

### **27.1 GENERAL TERMS**

The Rowing competitions shall be organised in accordance with the most recent technical regulations of the "Fédération Internationale des Sociétés d'Aviron" (FISA). In any dispute the English text shall be regarded as authoritative, except for the regulation concerning the coxswains, who may be of either gender for the FISU World University Championships.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last two (2) days and include the following events, following the *Avis de régates*:

#### **Men**

Single sculls (M1x)  
Double sculls (M2x)  
Pair (M2-)  
Four (M4-)  
Eight (M8+)

Lightweight

Single Sculls (LM1x)  
Double sculls (LM2x)  
Four (LM4-)

#### **Women**

Single sculls (W1x)  
Double sculls (W2x)  
Pair (W2-)  
Four (W4-)

Lightweight

Single sculls (LW1x)  
Double sculls (LW2x)

#### **Mixed Men & Women**

Mixed Quadruple-scull (M/W4X)

Each country is authorised to present a maximum of one (1) crew per event.

The delegation may include officials in proportion to the number of participants entered as follows:

Up to nine (9) participants	two (2) officials
Up to twenty (20) participants	four (4) officials
Over twenty (20) participants	five (5) officials

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

The Organising Committee guarantees that it will provide the necessary boats to participants coming from a continent other than the one of the host country. It is also recommended that the OC has a boat renting service on regatta centre on earlier demands for the country of the same continent.

## **27.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

Should the number of crews taking part in an event exceed the number of available starting positions, a progression system or time trials shall be applied.

In each event, there shall be a two-hour interval between two rounds.

The progression systems to be used during the regattas of the World University Rowing Championship shall be prescribed in the FISA Rules of Racing (the Bye-Laws to Rule 62 and Appendix 3).

The draw for the first round of heats shall take place during the General Technical Meeting to be held, in principle, on the day before the first heat. The draw shall be random.

If an event has less than seven (7) entries at the time of the draw, there shall be a preliminary race to determine the lanes for the final.

The draw shall be carried out using the software used by the official timing provider of the event.

If a crew withdraws after the draw up until one (1) hour before the start of the first heat and if the number of crews remaining in the event involves another variant of the heats and repêchages, or if such withdrawal results in an avoidable imbalance between the number of crews in each heat, FISU Technical Delegates shall hold a new draw.

In all other aspects not regulated above, the FISA Rules of Racing should be referred to.

## **27.3 TECHNICAL OFFICIALS**

### **27.3.1 Nomination:**

The jury shall be appointed by the FISA Umpiring Commission in agreement with the FISU Technical Delegates. The jury members shall hold an international umpire's licence.

### **27.3.2 Costs**

The cost of board and lodging for jury members (ITOs) should be borne by the Organising Committee from two (2) days prior to the first race until one (1) day after the last race.

The Organising Committee shall provide a travel subsidy to all jury members as determined by FISA. The total amount of the travel costs will be covered by the participating countries at the pro rata of athletes registered.

### **27.3.3 Number of technical officials needed and qualification**

The jury shall consist of one (1) President of the jury and eighteen (18) members. The President of the jury shall be an umpire nominated by the host country and hold an international umpire's licence.



## **28. RUGBY SEVENS**

### **28.1 GENERAL TERMS**

The Rugby Sevens tournaments shall be organised in accordance with the most recent World Rugby technical regulations. In any dispute the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last three (3) days and include:

- One (1) men's tournament
- One (1) women's tournament

Each country selected is authorised to enter:

Men's tournament: - One team of twelve (12) players  
Women's tournament: - One team of twelve (12) players

Each country is authorised to enter a maximum of sixteen (16) persons: up to twelve (12) competitors and up to four (4) officials per team.

The selection of the teams shall be fixed by the Executive Committee.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **28.2 PRE-COMPETITION PROCEDURE**

The countries participating in the Rugby Sevens tournament shall pay a deposit of EUR 5,000 per team to guarantee registration (Art. 5.4.4).

This deposit shall be paid to FISU at the latest five (5) months prior to the start of the Championship; failing this, the entries shall not be taken into consideration.

The participating teams shall be seeded as per the final standings of the previous Championship. Non-seeded teams shall be ranked amongst themselves according to the World Rugby ranking.

The draw shall take place once the team selection is made official.

### **28.3 TECHNICAL OFFICIALS**

#### **28.3.1 Nomination**

Referees shall be appointed jointly by World Rugby and the FISU Technical Delegates.

#### **28.3.2 Costs**

The participating delegations shall bear their costs of travel, board and lodging in proportion to the number of teams registered (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – World Rugby partnership agreement.

The Organising Committee shall announce the exact sum shortly after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

#### 28.3.3 Number of Technical Officials needed and qualification

For a 16-team competition, eight (8) referees, twelve (12) assistant referees and four (4) in-goal touch judges are needed.

In addition to the officials on the pitch, the local Rugby Union/Federation shall appoint a match management team composed of fifteen (15) persons, regardless of the number of participating teams.

The local Rugby Union/Federation shall also appoint other technical officials such as the manager for ballboys/ballgirls, together with three (3) teams of six (6) ballboys/ballgirls, eighteen (18) in total.

Two (2) citing officers and one (1) judicial officer shall be appointed to supervise the disciplinary process.

These appointments shall be made at the international level and approved by the IF.

## **29. SAILING**

### **29.1 GENERAL TERMS**

The Sailing competition shall be organised in accordance with the most recent technical regulations (RSS) of the International Sailing Federation (ISAF). In the event of a dispute, the English text shall be regarded as authoritative.

The programme and duration of competitions shall be fixed by the FISU Executive Committee in agreement with the Organising Committee and the CTI. In principle, the competitions shall last minimum six (6) days and include at least one of the two (2) following disciplines:

#### **Match Racing**

One day to examine the equipment;  
Matches organised in pools for the open category (men's or mixed crews)  
Matches organised in pools for the women category;  
Classification matches for the open category;  
Classification matches for the women category.

#### **Fleet Racing**

One day: entry and training;  
Three days: qualifying stage with four (4) groups;  
Two days: final stage with two (2) groups (including medal race).

A country may enter the following in each discipline:

#### **Match Racing**

A country may enter a maximum of four (4) teams as follows:

- Two (2) open crews with a maximum of eight (8) competitors and five (5) officials.
- Two (2) women's crews with a maximum of ten (10) competitors and five (5) officials.

If only one open team participates, the maximum shall be four (4) competitors and two (2) officials.

If only one women's team participates, the maximum shall be five (5) competitors and two (2) officials.

Crews shall consist of four (4) persons in the Open category and four to five (4 to 5) in women's (according to the boat selected for the Championship, the WUC Department may decide to fix this number to three (3) or five (5) persons).

The average weight of open competitors shall not exceed 87.50 kg.  
The average weight of women's competitors shall not exceed 68.00 kg.

Except upon a decision by Cisca, the skipper shall not be replaced during the Championship.

Prior to the selection of teams, the OC and the FISU Technical Delegate shall set the number of participating teams in proportion to the number of boats. In principle, the number will be sixteen (16) teams in Open category and ten (10) in women's category.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

The boats shall be supplied by the Organising Committee, with motorboats being reserved for trainers if needed.

### **Fleet Racing**

A country may enter a maximum of three (3) teams as follows:

The delegation shall be a maximum of fifteen (15) competitors and four (4) officials

- If only two (2) teams participate, the maximum shall be ten (10) competitors and three (3) officials;
- If only one (1) team participates, the maximum shall be five (5) competitors and two (2) officials.

The number of crew members on board must remain the same throughout the competition. Crews shall consist of four (4) or five (5) persons, including at least one woman and one man.

The weight of the crew is limited to 350 kg maximum (this weight may change according to the boat).

Excepting a Cisca decision, the skipper cannot be replaced during the championship.

Prior the selection of teams, the OC and the FISU Technical Delegate shall fix the number of participating teams in proportion to the number of boats.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of the competitors accredited by the CIC.

The boats shall be approximately 8m long and supplied by the Organising Committee, with motorboats being reserved for trainers.

The OC must foresee the provision of a minimum of 12 sailing boats and maximum 20, accepting 24 to 40 teams.

## **29.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

Priority shall be given to the entry of one (1) crew per country. This first list shall be validated by the OC and TD three (3) months before the event. Then, the remaining places shall be given according to the date of payment of the deposit to the OC and the world ranking of the skipper.

### Drawing

### **Match Racing**

Following the ISAF policy, boats shall be drawn every day or at the end of each pool.

Teams shall be ranked using the round robin system according to the last ISAF world ranking edited 10 days before the event.

Skippers without any world ranking shall be ranked in the group according to the results of the previous WUC.

### **Fleet Racing**

Boats shall be drawn according to the pairing list of the Sailing Instructions.

## **29.3 TECHNICAL OFFICIALS**

### **29.3.1 Nomination and costs**

International judges shall be appointed jointly by ISAF and FISU. The Organising Committee shall bear their costs of travel, board and lodging (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – ISAF partnership agreement.

The OC shall nominate and cover all costs related to the NTOs.

The international judge “Chief Umpire” (Match Racing) or "Jury Chairman "(Fleet Racing) shall not be a national of the organising country.

The ISAF representative can be a member of the umpire or jury team.

The race officer shall be a national of the organising country.

### **29.3.2 Number of ITOs**

#### **Match Racing**

According to the number of boats, the number of international umpires shall be between four (4) and six (6). This group shall include three (3) international judges (IJ) responsible for setting up the international jury.

#### **Fleet Racing**

The jury is made up to five (5) judges, including at least three (3) foreign international judges to set up the international jury

## 30. SAMBO

### 30.1 GENERAL TERMS

The Sambo competitions will be organised in accordance with the most recent technical regulations of the "Fédération Internationale de Sambo" (FIAS). In case of disagreement in the interpretation of these rules, the English text will be regarded as authoritative.

The programme and duration of the competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI-UE. The competitions shall last three (3) days and include the following individual events:

The teams must be composed of competitors who are also participating in the individual categories.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors.

## **30.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

The OC shall conduct the draw directly after the official registration in the presence of the FISU Technical Delegate (or his/her representative). Each completed master sheet shall be signed by the FISU Technical Delegate.

The draw shall be carried out using the FIAS - approved computerised random process, with the exception that the corresponding finalists of the previous Championships are separated as widely as possible.

Entries for the draw shall come from the FISU online registration system.

After the draw is completed and signed by the FISU Technical Delegate, it shall be made available for each participating country.

## **30.3 TECHNICAL OFFICIALS**

### **30.3.1 Nomination and costs**

All international referees and judges are nominated by the FIAS Referees Commission under the supervision of FISU.

Travel expenses, accommodation, full board and the allowances according to the regulations of the ISF for all international judges are borne by FIAS.

NTOs are appointed by the National Sambo Federation. Organising Committee will cover their travel expenses, accommodation and full board.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last five (5) days and include the following events:

## **31.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

### **Format of competition**

Qualification rounds: The events shall be completed in individual as well as team. In the 50m events, if entries exceed the expected number, elimination rounds shall be conducted.

Final rounds: All the Olympic events shall be conducted as finals. The eight highest-scoring shooters in the qualification rounds of rifle and pistol individual events shall qualify for the finals. For the rapid fire pistol men's event and the shotgun event, the six highest-scoring shooters shall qualify for the final.

The non-Olympic events shall be conducted without the finals rounds.

Team events shall be ranked from the results list of the preliminary rounds / elimination or qualification/.

Shooters have to mention in the entry forms in which discipline of the events they will participate: individual event, team event, or both.

The ITOs shall be appointed jointly by the ISSF TD and the FISU Technical Delegate. The Organising Committee shall bear their costs of travel, board and lodging (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – FIS partnership agreement.

The Organising Committee must invite the ITOs no later than three (3) months before the opening ceremony shall announce the exact sum after the closing date for individual entries (one (1) month before the beginning of the World University Championship).

In case of disagreement in the interpretation of the rules, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last five (5) days and include the following events:

- Men:
- Individual sprint distance race
  - Individual pursuit distance race
  - Individual middle distance race – mass start
- Women:
- Individual sprint distance race
  - Individual pursuit distance race
  - Individual middle distance race – mass start
- Mixed:
- Sprint relay race

Each country may enter a maximum of twenty-one (21) persons: sixteen (16) competitors (with a maximum of eight (8) men and eight (8) women) and five (5) officials.

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

#### **33.3 TECHNICAL OFFICIALS**

A jury consisting of three (3) team officials shall be appointed at the first General Technical Meeting.

The IOF Technical Delegate shall chair the jury without voting rights.  
The jury shall remain the same throughout the competition week.

## **34. SPEED SKATING**

### **34.1 GENERAL TERMS**

The Speed Skating events shall be organised in accordance with the technical regulations of the International Skating Union (ISU). In any dispute the English text shall be regarded as authoritative.

The programme and duration of competitions shall be fixed by the Executive Committee in agreement with the Organising Committee and the CTI. In principle, the programme shall last a maximum of four (4) days with an additional reserve day, in case of bad weather, may the event be organised outdoor. The event shall include the following events:

Men: 500m, 1,000m, 1,500m, 5,000m, 10,000m, mass-start, team pursuit races over 8 laps for national teams of 3 skaters, team pursuit sprint (optional)

Women: 500m, 1,000m, 1,500m, 3,000m, 5,000m, mass-start, team pursuit races over 6 laps for national teams of 3 skaters, team pursuit sprint (optional).

The 500m for Ladies and Men will be skated twice. The classification will be based on the total time of the 2 races (see also ISU Rule 265, paragraph 1b).

Each country may enter a maximum twenty-nine (29) persons: twenty-four (24) competitors (twelve (12) men and twelve (12) women) and five (5) officials.

Each country may enter per gender category:

Men: Five (5) athletes for each distance, but no more than four (4) may start in the 500m, 1,000m, and 1,500m, and no more than three (3) in the 5,000m and 10,000m. For the mass-start events, two (2) skaters. If necessary, the number of competitors may be reduced. The total number of competitors from any country shall not exceed twelve (12).

Women: Five (5) athletes for each distance, but not more than four (4) may start in the , 500m, 1,000m, 1,500m, and three (3) in the 3,000m and 5,000m. For the mass-start events, two (2) skaters. If necessary, the number of competitors from any country may be reduced. The total number of competitors shall not exceed twelve (12).

For the women's 3,000m and the men's 5,000m, a maximum of thirty-two (32) skaters shall be permitted in each event.

For the women's 5,000m and the men's 10,000m, a maximum of sixteen (16) skaters shall be permitted in each event.

For the team pursuit event, a maximum of eight (8) national teams (men and women) shall be authorised to take part in the competition (four (4) skaters in each team, three (3) of whom may skate). The qualification of the teams shall be based on the ranks of the second best skater of the country concerned in the 3,000m for women and in the 5,000m for men.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

## **34.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

All procedures regarding the draw shall follow the ISU speed skating technical regulations.

## **34.3 TECHNICAL OFFICIALS**

### **34.3.1 Nomination**

Referees, assistant referees, the starter and the assistant starter shall be appointed by the ISU in close cooperation with the Organising Committee and the FISU Technical Delegate. They shall be invited by the OC no less than three (3) months before the start of the World University Championship.

### **34.3.2 Costs**

All countries participating in the speed skating WUC shall bear a proportion of the costs of:

- 2 referees from the ISU champions list (A-list)
- 2 assistant referees from the ISU champions list or ISU list of international competitions (B-list)
- 2 starters from the ISU champions list.
- 2 starters from the ISU champions list or ISU list of international competitions.

The total amount of costs shall be divided by the total number of participants and all participating countries shall pay their share in proportion to the number of their participants.

The Organising Committee shall announce the exact sum after the closing date for quantitative entries (three (3) months before the beginning of the World University Championship).

### **34.3.3 Number of technical officials needed**

The number of officials needed shall respect the ISU rule 210.

The OC in cooperation with the National Ice Skating Federation must provide a sufficient number of Judges for the races and for all the competition days.



## **35. SPORT CLIMBING**

### **35.1 GENERAL TERMS**

The Sport Climbing competitions shall be run in accordance with the most recent technical regulations of the “International Federation of Sport Climbing” (IFSC).

The programme and duration of competitions are fixed by the FISU Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last four (4) days and include as a minimum two (2) of the following events:

Men’s and women’s events:

- Bouldering
- Lead
- Speed

The Organising Committee shall propose a list of events and disciplines to the FISU Executive Committee at the latest eighteen (18) months prior to the Championship.

Each country may enter a maximum of thirty (30) athletes (five (5) per gender and discipline).

The delegation may register a maximum of five (5) team officials. These officials must be specifically nominated for one of the following roles:

- a) One (1) team manager;
- b) Two (2) team coaches;
- c) Two (2) qualified medical or para-medical personnel.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm the official list of competitors accredited by the CIC as per the IFSC procedure.

Every competitor and delegation officials must have an IFSC international licence that is valid for the year of the Championship and issued by his/her national federation, which shall be affiliated to the IFSC.

### **35.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

All procedures concerning the registration and the start list set-up shall follow the IFSC procedures. The schedule of registration deadlines shall follow the FISU regulations.

### **35.3 TECHNICAL OFFICIALS**

#### **35.3.1 Nomination and costs**

Referees shall be appointed jointly by the IFSC and FISU. The Organising Committee shall bear their costs of travel, board and lodging (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – IFSC partnership agreement.

### 35.3.2 Number of technical officials and qualification

The number of technical officials needed is specified per discipline and per event in the following table.

## **36. SQUASH**

### **36.1 GENERAL TERMS**

The Squash championships shall be organised in accordance with the relevant World Squash Federation (WSF) championship regulations, unless otherwise stated.

The programme and duration of competitions will be determined by the FISU Executive Committee in agreement with the Organising Committee and the CTI.

The maximum duration of the Championships (individual and team) shall be seven (7) days, and include:

#### **36.1.1 Individual Championships (men & women)**

These championships shall comprise separate men's and women's singles championships, and permit a maximum of 3 male and 2 female entries per nation.

The duration of the event may vary, but usually last 3-4 days.

#### **36.1.2 Team Championship (mixed teams)**

Teams shall comprise 2 male and 1 female player selected from a maximum playing squad of 3 male and 2 female players. Squad submission and team nomination shall follow WSF Regulations unless otherwise specified.

NB. Nations may enter up to 8 players in total, so may choose to nominate different players for individual and team events, or they may nominate the same 3 male and 3 female players to compete in both individual & team events.

#### **36.1.3 Officials**

Each participating nation may register up to 5 officials, including Head of Delegation, coaches, and team manager, medical or other relevant support

#### **36.1.4 Tin Heights**

All men's matches (individual & teams championships) will be played with 17" tin, and women's with 19" tin.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

## **36.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

Seeding and draw arrangements for the Individual Championships shall follow WSF World Championship Regulations. Nations will be asked to provide relevant information on each player's recent form at time of entry to assist the Seeding Committee.

The seeding and draw for the Team Championship shall take place the day before the start of the event. The seeding will be informed by the seeding for and results of the Individual Championships.

## **36.3 TECHNICAL OFFICIALS**

### **36.3.1 Nomination and costs**

The host shall provide 18 referees to cover individual and team Championships, comprising the following qualifications:

- at least 2 WSF (world) referees, to be appointed by the WSF, at least one from a nation other than the host nation
- at least 2 regional referees, to be appointed in conjunction with the WSF &/or WSF region, at least one from a nation other than the host nation
- up to 12 additional referees should be current national grade

All costs for the 2 world/regional referees from outside the host nation shall be shared by the participating delegations.

All costs for referees from the host nation shall be borne by the Organising Committee. If the host nation does not have sufficient referees of at least National grade, they must import them at the cost of the OC.

A participating nation may request to bring a referee as part of its delegation of officials (at its own cost), but the request will be subject to approval by the TD & OC, must be made at least 4 months prior to the event, and accompanied by certification of the referee's current level of qualification (at least National).

Other costs are referenced in the FISU – WSF partnership agreement.

## **37. TRIATHLON**

### **37.1 GENERAL TERMS**

The Triathlon competitions shall be run in accordance with the most recent technical rules of the International Triathlon Union (ITU), unless otherwise stated. In case of disagreement in the interpretation of the rules, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last one (1) day and include the following events:

#### Men:

Individual race, Olympic distances (1.5 km swimming, 40 km cycling and 10 km running);

Team classification

#### Women:

Individual race, Olympic distances (1.5 km swimming, 40 km cycling and 10 km running);

Team classification

Each country may enter a maximum of seventeen (17) persons: twelve (12) competitors and five (5) officials.

Each country may enter:

Men: a maximum of six (6) competitors in the individual race

Team classification is based on the individual results: the total team time is the addition of the 3 best times of the athletes from the same nation and gender. In case of a tie, the time of the third team member will determine the team result. Only one (1) team per country is rated.

Women: a maximum of six (6) competitors

Team classification is based on the individual results: the total team time is the addition of the 3 best times of the athletes from the same nation and gender. In case of a tie, the time of the third team member will determine the team result. Only one (1) team per country is rated.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **37.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

The athlete's race numbers are assigned based on previous race results in similar events.

The elite men's and women's events shall be numbered starting with number 1; number 13 shall not be used.

Order of criteria for seeding:

- Current WTS rankings
- ITU points list
- Random

### **37.3 TECHNICAL OFFICIALS**

#### **37.3.1 Nomination**

The ITOs shall be appointed jointly by the ITU and FISU.

#### **37.3.2 Costs**

The costs of those referees shall be borne by the Organising Committee.

#### **37.3.3 Number of technical officials needed**

Race officials are assigned to start/finish, transition area(s), swim, cycle, run, wheel stations, aid stations and vehicle control.

An adequate number of race officials shall be assigned to each area. They shall be responsible for the enforcement of ITU Competition Rules within their assigned jurisdiction.

## **38. WATERSKI**

### **38.1 GENERAL TERMS**

The Waterski competitions shall be run in accordance with the most recent technical rules of the International Waterski and Wakeboard Federation (IWWF), unless otherwise stated. In the event of a disagreement on the interpretation of the rules, the English text shall be regarded as authoritative.

The programme and duration of competitions will be fixed by the Executive Committee in agreement with the Organising Committee and the CTI. In principle, the competitions shall last five (5) days and include the following events:

Team classification

Each country may enter a maximum of thirteen (13) persons: eight (8) competitors and five (5) officials, with at least two (2) competitors of the opposite gender and up to 2 substitutes.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **38.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

The draw of order shall follow IWWF regulations.

### **38.3 TECHNICAL OFFICIALS**

#### **38.3.1 Nomination and costs**

Referees shall be appointed jointly by IWWF and the FISU Technical Delegate. The Organising Committee shall bear their costs of travel, board and lodging (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – IWWF partnership agreement.

## **39. WEIGHTLIFTING**

### **39.1 GENERAL TERMS**

The Weightlifting competitions shall be organised in accordance with the most recent Technical and Competition Rules & Regulations of the International Weightlifting Federation (IWF). In any dispute, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last four (4) days and include:

#### **Men**

56kg, 62kg, 69kg, 77kg, 85kg, 94kg, 105kg, +105kg

#### **Women**

48kg, 53kg, 58kg, 63kg, 69kg, 75kg, +75kg

The competition shall include the following sequences:

- a) the snatch
- b) the clean and jerk

Gold, silver and bronze medals shall be awarded in snatch, clean and jerk and total.

A Team Classification may/shall be calculated as per the IWF TCRR, and trophies may/shall be awarded to the top 3 (three) teams by gender.

Individual "Best Lifter" awards may be offered by the Organising Committee at their own discretion.

Each country is authorised to enter a maximum of twenty (20) persons: eight (8) male competitors and seven (7) female competitors spread over the different categories, with a maximum of two (2) competitors per category, and five (5) officials.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **39.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

Drawing method: prior to or during the General Technical Meeting, a verification of final entries (VFE) shall take place. After the VFE a randomly generated lot number is drawn for each verified athlete.

For the production of the start list, the competition management, scoring and results, an IWF-approved technology system and software shall be used.

### **39.3 TECHNICAL OFFICIALS**

#### **39.3.1 Nomination and costs**

International Technical Officials (ITOs) shall be appointed jointly by IWF and the FISU Technical Delegate. The Organising Committee shall bear their costs of board and lodging (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

ITOs shall arrange and bear their own travel expenses.

Other costs are referenced in the FISU – IWF partnership agreement.

#### **39.3.2 Number of technical officials needed**

A minimum of thirty (30) ITOs are needed, of which a minimum of twenty-six (26) shall be from a country other than the host country. Approximately 12-15 NTOs are needed.

## **40. WOODBALL**

### **40.1 GENERAL TERMS**

The Woodball competitions shall be run in accordance with the most recent technical rules of the International Woodball Federation (IWbF), unless otherwise stated. In the events of a disagreement in the interpretation of the rules, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last six (6) days and include the following events:

- Stroke competition
- Fairways competition

Each country may enter a maximum of seventeen (17) people: twelve (12) competitors (six (6) men and six (6) women) and five (5) officials.

In each event, each country may enter:

Stroke competition

Men:

- Individual event: six (6) competitors;
- Team event: six (6) competitors.

Women:

- Individual event: six (6) competitors;
- Team event: six (6) competitors.

Fairway competition\*:

- Four (4) singles: Men's / Women's (2 each)
- Two (2) pairs: men's doubles
- Two (2) pairs: women's doubles
- Two (2) pairs: mixed doubles

\*In Fairway competition, each player may enter a maximum of 2 events.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **40.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

#### **40.2.1 Drawing method**

1. No more than four (4) athletes in one (1) flight;
2. No more than one (1) athlete from the same country in a flight.

#### 40.2.2 Method

1. All countries and athletes shall be assigned a number

- A1, A2, A3, A4, A5, A6
- B1, B2, B3, B4, B5, B6 ...

2. The flights shall be drawn as below:

- A1, B1, C1, D1
- E1, F1, G1, A2
- B2, C2, D2, E2
- F2, G2, A3, B3 ...

The flights shall be drawn at least one (1) day before an event.

### **40.3 TECHNICAL OFFICIALS**

#### 40.3.1 Nomination

Referees shall be appointed jointly by IWbF and the FISU Technical Delegate. The participating delegations shall bear their costs of travel, board and lodging in proportion to the number of athletes registered (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – IWbF partnership agreement.

The Organising Committee shall announce the exact sum shortly after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

#### 40.3.2 Number of technical officials needed and qualification

##### a) Chief referee

One (1) chief referee who shall have the qualification or international licence of IWbF and experience in serving as a referee in international competitions for at least ten years.

##### b) Referees

A total of twelve (12) referees is required to officiate at the twelve (12) fairways; these referees shall have the qualification or international licence of IWbF.

##### c) Linesmen

A total of twelve (12) linesmen is required to assist the referees at the fairways; these linesmen shall have good knowledge of Woodball.

##### d) Technical workshop

A technical workshop, to be conducted by the chief referee, shall be held at least one (1) day before the competition starts; all referees and linesmen shall attend this workshop.

## **41. WRESTLING**

### **41.1 GENERAL TERMS**

The wrestling competitions shall be organised in accordance with the most recent technical regulations of the "United World Wrestling" (UWW). In any dispute the French text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last five (5) days and include individual events in the following weight categories:

<u>Men:</u>	Free style - 57kg, - 61kg, - 65kg, - 70kg, - 74kg, - 86kg, - 97kg, - 125kg
	Greco-Roman style - 59kg, - 66kg, - 71kg, - 75kg, - 80kg, - 85kg, - 98kg, - 130kg
<u>Women:</u>	Free style - 48kg, - 53kg, - 55kg, - 58kg, - 60kg, - 63kg, - 69kg, - 75kg

A team ranking shall award a trophy to the best three (3) teams in each style.

Each country is authorised to enter one (1) competitor and one (1) reserve for each weight category, and five (5) officials. The same competitor may take part in both styles.

The countries shall declare their starters to the Technical Committee six (6) hours before the official weigh-in.(until 12:00 pm in the weigh-in day)

Each athlete shall bring a UWW licence that is valid for the current year, and present it to the Technical Committee.

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors accredited by the CIC.

### **41.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

The draw shall be made during the official weigh-in using the Heracles software.

### **41.3 TECHNICAL OFFICIALS**

#### **41.3.1 Nomination and costs**

Referees shall be appointed jointly by UWW and the FISU Technical Delegate. The participating delegations shall bear their costs of travel, board and lodging in proportion to the number of athletes registered (from two (2) days before the opening ceremony to one (1) day after the closing ceremony).

Other costs are referenced in the FISU – UWW partnership agreement.

The Organising Committee shall announce the exact sum shortly after the closing date for nominative entries (one (1) month before the beginning of the World University Championship).

#### 41.3.2 Number of technical officials needed

Minimum thirteen (13) referees per mat shall be appointed.

## 42. WUSHU

### 42.1 GENERAL TERMS

The Wushu competitions shall be organised in accordance with the most recent technical rules of the International Wushu Federation (IWUF). In case of disagreement in the interpretation of these rules, the English text shall be regarded as authoritative.

The programme and duration of competitions are fixed by the FISU Executive Committee in agreement with the Organising Committee and the CTI. The competitions shall last four (4) days and include the following events:

#### **Men**

##### Taolu (Routines):

1. Changquan
2. Daoshu & Gunshu Combined
3. Nanquan & Nangun Combined
4. Taijiquan & Taijijian Combined

##### Sanda (Free Fighting):

1. 52 kg division
2. 60 kg division
3. 70 kg division
4. 80 kg division

#### **Women**

##### Taolu (Routines):

1. Changquan
2. Jianshu & Qiangshu Combined
3. Nanquan & Nandao Combined
4. Taijiquan & Taijijian Combined

##### Sanda (Free Fighting):

1. 52 kg division
2. 60 kg division

The duration of events is as follows for both men and women.

##### Taolu (Routines):

For Changquan, Daoshu, Gunshu, Jianshu, Qiangshu, Nanquan, Nangun & Nandao, each routine's duration shall be no less than one minute and twenty seconds.

For Taijiquan and Taijijian, each routine's duration shall be between three to four minutes.

##### Sanda (Free Fighting):

Each bout consists of 3 rounds. Each round consists of 2 minutes of combat time (excluding stoppage time). There will be a 1 minute rest period between each round. An athlete will be determined to have won a bout by winning two rounds; or by knock-out of his/her opponent; or by technical victory as stipulated in the "Rules for International Wushu Sanda Competition".

Each participating country may enter a maximum of twelve (12) participants: eight (8) athletes and four (4) officials.

Officials: one (1) team leader, two (2) coaches (1 taolu coach only; 1 sanda coach only) and one (1) doctor.

Athletes: four (4) taolu athletes (maximum one (1) athlete per medalling taolu event) and four (4) sanda athletes (maximum one (1) athlete per weight division, with a limit of three (3) male sanda athletes in total).

The host country may submit a total of eight (8) taolu athletes (maximum one (1) athlete per medalling taolu event) and six (6) sanda athletes (maximum one (1) athlete per weight division).

At the first General Technical Meeting, the Head of Delegation or his/her representative shall confirm and sign the official list of competitors.

## **42.2 PRE-COMPETITION PROCEDURE**

Three (3) months before the Championship, the Organising Committee has the right to collect 25% of the total cost of stay per athlete and official from participating countries.

## **42.3 TECHNICAL OFFICIALS**

### **42.3.1 Nomination and costs**

ITO's shall be appointed jointly by IWUF and FISU. Their cost (travel, per diem and full board) will be covered by the IWUF.

NTOs shall be appointed by the host country's National Wushu Federation. The Organising Committee will cover their travel expenses, accommodation and full board.

Other costs are referenced in the FISU – IWUF partnership agreement.

### **42.3.2 Number of technical officials needed**

A minimum of 33 ITO shall be appointed:

- Technical Delegate (1 person); Jury of Appeal (3 persons); Chief Referees (3 persons); Head Judges (3 persons); Judges (20 persons); Chief Scheduler/Recorder (2 persons); Medical Supervisor (1 person).

A minimum of 18 NTO shall be appointed:

- Schedulers (6 persons); Chief Recorders (2 persons); Recorders (8 persons); Announcers (2 persons).
