# HOW WE GOT HERE

- Challenges of the last year
- Necessity of Project:
  - New Recruiting Regulations
  - External Relationships
  - Administration of Eligibility and National Championships
- Project Already Paying Dividends:
  - Some institutions were not collecting mandatory information
  - Some institutions were not having Student-Athlete Acknowledgment and Consent form signed
- Let's talk about “how”, not “whether”



# U SPORTS CENTRAL - TODAY

- Declaration of Participation due June 15
- Registration of 2016-2017 Student-Athletes by June 30
- Enhanced Consultation Process: Task Force plus calls and individual tests
  - Working with John Bower: Athletic Department perspective; tech experience; bilingual
- 2017-2018 Eligibility Certificate and Academic All-Canadian Award processes being brought online



# U SPORTS CENTRAL – TODAY

- Addressing Institution Questions/Concerns
  - Each Member has unique questions/concerns
  - Differences from every perspective - tech, administration, priorities
  - Questions being addressed promptly, flexibly
- Privacy Issues – Addressed in detailed memo
  - Outstanding issues to be raised with COO
  - Another great example of differences between institutions
- Fees to populate the database:
  - \$5 per current student-athlete (paid by institution);
  - \$50 per prospective student-athlete (paid by recruit);


