# Eligibility & AFA Alignment.



### Synopsis.

- Key goals continue to be:
  - Ability to support more student-athletes entering into U SPORTS through the reduction of entry barriers
  - Follow the U SPORTS EDI Committee's recommendation to remove the 80% barrier
  - Reduction in administrative tasks for both entering and year-to-year studentathlete AFA & eligibility qualification
- Appear to continue to have the mandate of the membership to find a pathway forwards to achieve the two goals listed above

"Institutional barriers previously identified as preventing students from engaging in quality learning outside of the traditional classroom setting include, but are not limited to, a lack of administrative support... and other challenges related to finances, time commitments, equity and access." (Stirling et al., 2021: 271-272).







### Options Provided in Survey.

### Entering:

- 1. If admitted into university and enrolled in a degree-granting credits, the student- athlete is eligible to Participate and receive an AFA (note: this option would remove the Spring Award entirely)
- 2. If admitted into and enrolled in a degree-granting program, the student-athlete is eligible to Participate and receive an AFA; or, if not admitted into and enrolled in a degree-granting program (but taking degree-granting credits), the student-athlete is eligible and can only receive a Spring Award if they meet the Year-to-Year requirements (ie: 21 CR with a 65% average, if that's selected).
- 3. If admitted into a degree-granting program, the student-athlete is eligible to Participate and receive an AFA; or, if not admitted into a degree-granting program, but admitted to the university and taking degree-granting credits, the studentathlete is only eligible to Participate and an AFA if they have an entry average of 65(?)%; or, if not admitted into a degreegranting program, and do not have an entry average (eg: entered through a mature student application), the student- athlete is not eligible for Participation, and cannot receive an AFA that academic year. They are able to receive an AFA and are eligible to Participate in Year 2 if they meet the Year-to-Year requirements.

### Year-to-Year:

- Successfully complete 18 degree-granting credits (no GPA)
- Successfully complete 18 degree-granting credits (with 60-65% GPA)
- Successfully complete 21 degree-granting credits (no GPA)
- Successfully complete 21 degree-granting credits (with 60-65% GPA)
- Successfully complete 24 degree-granting credits (no GPA)
- Successfully complete 24 degree-granting credits (with 60-65% GPA)
- Maintain full-time student status in a degree-granting program







# Alignment. Summary of survey.

### **ENTERING**

- No clear consensus, but option 3 can be eliminated, having received 11%
- Option 1 is the most popular as an option 1 at ~55%
- Option 2 received ~35%, but also received ~52% of second option votes in ranked ballot
- When looking at the ranked ballot, Options 1 & 2 came in equally

### YEAR-TO-YEAR

The majority of institutions appear to support 18-21 credits, either with or without a GPA attached, but appear not to be in support of moving to 24 or to full-time program of study

### ISSUES WITH ENTERING STUDENTS OPTIONS


- The apparent removal of academic requirements was untenable for them;
- Entry immediately into an open studies or alternative but not into a program of study – is common at my institution, and I am concerned by options 2 and 3;
- Student-athletes who were deemed ineligible upon entry would not stick around;
- The removal of the spring award is a concern; and,
- Retaining the spring award is a concern;

### Summary of survey.

### ISSUES WITH YEAR-TO-YEAR STUDENTS OPTIONS

- There must be a GPA requirement;
- Progress towards degree is the most important metric / goal;
- A heightened credit requirement would be problematic as student-athletes need to be able to work in the summers, etc., and the pressures associated with aligning eligibility to participate with a higher credit requirement would be problematic;
- The submitting institution has a GPA requirement in place; and,
- Attaching a GPA requirement to athletic participation (year-to-year eligibility criteria) would be problematic.



# Member Engagement. Proposal.

- · Only the Entering Student category is addressed at this time
- Options 1 & 2 are discussed, and we eliminate Option 3
- That a motion be sent to the Board for the September 2023 meeting for implementation in the 2024-2025 Academic Year
  - This will ensure that we make progress towards reducing barriers for entering students
- That the AFA & Eligibility Committees continue to move towards addressing the Year-to-Year requirements, but that they stay status quo for the time being
- That there be no changes to Team and Individual Caps, or the Academic All-Canadian Exemption for 2024-2025

### Remaining two options:

- If admitted into university and enrolled in a degree-granting credits, the student- athlete is eligible to Participate and receive an AFA (note: this option would remove the Spring Award entirely)
- 2. If admitted into and enrolled in a degree-granting program, the studentathlete is eligible to Participate and receive an AFA; or,




### **Equity in AFA Distribution.**

### Synopsis & Next Steps.

- This concept has been consistently discussed, but most recently discussed as a membership in 2018
- The AUS and OUA members and their respective Boards have requested that U SPORTS implement a policy to mandate gender equity in AFA distribution
- A policy itself would be "relatively simple" to create
- Following discussion at this Member Engagement Session, we will review the information, determine if there is sufficient information to proceed further, and would look to bring a motion to the September 2023 Board meeting


